This 'Privacy Policy' describes our policies and procedures on the collection, use and disclosure of 'Your information' when 'You' use the 'Service' and informs 'You' about 'Your privacy rights' and how the law protects 'You'.

We use Your Personal data to provide and improve the Service. By using the Service, You agree to the collection and use of information in accordance with this Privacy Policy. This Privacy Policy has been created with the Congolese Law n° 20/017 of 25 November 2020 on Telecommunications and ICT, as well as , where applicable, DIFC Data Protection Law No. 5 of 2020 (DIFC DP Law 2020) and the General Data Protection Regulation (GDPR)

# Interpretation and definitions

### Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

#### **Definitions**

For the purposes of this Privacy Policy:

- "Account" means a unique account created for You to access our Service or parts of our Service.
- "Company" (referred to as either "the Company", "We", "Us" or "Our" in this Privacy Policy) refers to Hadassah Transfer LLC, registered in the State of Illinois, USA, under number 05672392, and whose registered agent is INCORP SERVICES. INC., 901 S 2ND ST STE 201 SPRINGFIELD IL 62704-7909.
- "Cookies" are small files that are placed on your computer, mobile device or any other device by a website, containing the details of your browsing history on that website among its many uses.
- "Device" means any device that can access the Service such as a computer, a cellphone or a digital tablet.
- "Law of 25 November 2020" refers to the Congolese Law n° 20/017 of 25 November 2020 on Telecommunications and ICT
- "Personal Data" is any information that relates to an identified or identifiable individual, as defined under DIFC DP Law 2020.
- "Service" refers to the Website.
- "Service Provider" means any natural or legal person who processes the data on behalf of the Company.

- "It" refers to third-party companies or individuals employed by the Company to facilitate the Service, to provide the Service on behalf of the Company, to perform services related to the Service or to assist the Company in analyzing how the Service is used.
- "Website" refers to Hadassah Transfer LLC's website, accessible from https://usdrc.info/
- "You" means the individual accessing or using the Service, or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable.

# Legal basis for processing personal data

In accordance with the Congolese Law No. 20/017 of 25 November 2020 on Telecommunications and ICT, , we process personal data based on the following legal bases:

- Consent When You explicitly provide consent (e.g., subscribing to marketing emails, accepting cookies), as required by Article 132
- Contractual Necessity When processing is required to perform a contract with You (e.g., account creation, order fulfillment).
- Legal Obligation When processing is required to comply with obligations imposed by public authorities or regulatory laws in the DRC.
- Legitimate Interest When processing is necessary for our business operations and does not override Your rights (e.g., website analytics, fraud prevention).
- Public Interest or Official Authority Where required by competent national authorities or justified for national interest.

# Collecting and using your personal data

# Types of data collected

We collect the following categories of Personal Data:

- Contact information (e.g., full name, email address, phone number, mailing address)
- Usage data (e.g., IP address, browser type, page visits, time spent on pages, device identifiers)
- Technical data (e.g., operating system, network information, login credentials, device location if enabled)
- Marketing preferences (e.g., opt-in consent for newsletters, past interactions with our marketing materials)

### Data sharing

We may share your personal data with:

- Service Providers (e.g., cloud storage, analytics, payment processing).
- Hadassah Transfer LLC's Affiliates, strictly for operational, regulatory, security and service enhancement purposes, ensuring compliance with this Privacy Policy.

- Regulatory Authorities of the DRC, when required by law.
- Third parties, only with Your prior consent .

## Tracking Technologies and Cookies

We use Cookies and similar tracking technologies to track the activity on Our Service and store certain information. Tracking technologies used are beacons, tags, and scripts to collect and track information and to improve and analyze Our Service.

#### Cookies or Browser Cookies:

A cookie is a small file placed on Your Device. You can instruct Your browser to refuse all Cookies or to indicate when a Cookie is being sent. However, if You do not accept Cookies, You may not be able to use some parts of our Service. Unless you have adjusted Your browser setting so that it will refuse Cookies, our Service may use Cookies.

#### Flash Cookies:

Functionality Cookies

Type: Persistent Cookies

Purpose: These Cookies allow us to remember choices You make when You use the Website, such as remembering your login details or language preference. The purpose of these Cookies is to provide You with a more personal experience and to avoid You having to re-enter your preferences every time You use the Website.

### Performance and Analytics Cookies

These collect information about how visitors use our website, which pages are visited most frequently, and if error messages are received from web pages. These cookies help us improve our website.

### Advertising and Targeting Cookies

Used to deliver advertisements more relevant to you and your interests. They are also used to limit the number of times you see an advertisement and help measure the effectiveness of the advertising campaign.

We will retain and use Your Personal Data as necessary to comply with legal requirements, resolve disputes, and enforce our legal agreements and policies. Usage Data may be retained for internal analysis purposes, unless a longer retention period is required for legal or regulatory reasons, or to enhance the security and performance of Our Service

#### Security of Your Personal Data

The security of Your Personal Data is important to Us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While We strive to use commercially acceptable means to protect Your Personal Data, We cannot guarantee its absolute security.

# Children's Privacy
